APPROVED - RESOLUTION 01-45 - CANVASS OF BALLOTS DECLARING RESULTS OF ELECTION

Deputy City Clerk John Holt presented a report on the results of the March 6, 2001 General Municipal Election. Fresno County Clerk Victor Salazar formally presented the Certificate of the County Clerk certifying the results of the canvass from the March 6, 2001 election. There being no public comment, Mayor Armstrong closed the public portion. Motion by Councilmember Wynne, seconded by Councilmember Flores, that Resolution 01-45 (declaring the results of the March 6, 2001 election) be approved. Motion carried with Councilmember Stearns absent.

OATH OF OFFICE

City Clerk Michael Prandini administered the Oath of Office to the newly elected Councilmembers Lynne Ashbeck and Nathan Magsig.

ELECTION OF MAYOR BY CITY COUNCIL

City Clerk Michael Prandini opened the nominations for Mayor. Councilmember Wynne made a motion, seconded by Councilmember Magsig, that Councilmember Flores be nominated as Mayor. Councilmember Armstrong moved to close the nominations and to cast a unanimous vote. Motion carried.

Mayor Flores thanked members of the City Council and members of the community for their support and stated that the Council will make a great team. Mayor Flores introduced and thanked his wife, Shelley; sons Joe and Michael; daughter, Melana; mother Celia; brothers, and sister, and their children for helping make him what he is today.

ELECTION OF MAYOR PRO TEM BY CITY COUNCIL

Mayor Flores opened the nomination for Mayor Pro Tem. Councilmember Magsig made a motion, seconded by Councilmember Wynne nominating Lynne Ashbeck for Mayor Pro Tem. Councilmember Armstrong moved to close the nominations and to cast a unanimous vote. Motion carried.

City Manager Kathy Millison presented a report to consider the appointment of City Clerk. Kathy Millison indicated that in the 1997 election the citizens of Clovis approved an ordinance amendment which provided that the elected City Clerk be converted to an appointed position after the March 2001 election. Kathy Millison indicated that the elected term has expired and Council is required to make an appointment at this time. Kathy Millison indicated staff was recommending the appointment of Mike Prandini as City Clerk. There being no public comment, Mayor Flores closed the public portion. Motion by Councilmember Armstrong, seconded by Councilmember Ashbeck, that the Council appoint Mike Prandini as City Clerk. Motion carried.
